

## Assumption of the Risk and Waiver of Liability Relating to COVID-19

The novel coronavirus, COVID-19, is contagious and is believed to spread mainly from person to person contact. Camp Vista (CV) and Tatra Mountain Cultural Foundation (TMCF) has put in place preventative measures to reduce the spread of COVID-19, however, (CV)(TMCF) cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending summer program at Camp Vista could increase your risk and your child(ren)'s risk of contracting COVID-19.

I hereby willingly choose to participate in (CV)(TMCF) activities and abide by (CV)(TMCF) COVID-19 prevention procedures which include the following:

- a. I understand that if (CV)(TMCF) determines that a camper / volunteer/ staff member needs to go home, I as the parent am responsible to pick up that person within 6 hours of being notified.
- b. I understand that camp will do its best to offer as many activities as possible, but that programs and procedures will look different (often interrupted by social distancing requirement) from past years - before COVID-19 pandemic
- c. I understand that TATRA MOUNTAIN CULTURAL FOUNDATION faces additional costs related to COVID-19, and TATRA MOUNTAIN CULTURAL FOUNDATION will not issue any refunds for providing own transportation to camp, for the program possibly ending on Friday evening instead of Saturday morning (in case we have to do this because of the current virus), or for any other costs to parents related to COVID-19
- d. I understand that I will provide transportation for my child(ren):
  - For check-in at the camp on Sunday at 3:00PM
  - For check-out from the camp on Friday from 5:30PM to 7:00PM
- e. I acknowledge and understand that the circumstances regarding COVID-19 are changing "from day to day", and these changes might not be adopted immediately by TATRA MOUNTAIN CULTURAL FOUNDATION. I accept responsibility for familiarizing myself with the most recent updates at [www.tatrafoundation.org](http://www.tatrafoundation.org) website.

By signing this agreement, I acknowledge the contagious nature of COVID-19, and voluntarily assume the risk that my child(ren) and/or I may be exposed to or infected by COVID-19 by attending (CV)(TMCF), and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at (CV)(TMCF) may result from the actions, omissions, or negligence of others, including, but not limited to, (CV)(TMCF) employees, volunteers and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or child(ren) may experience or incur in connection with my child(ren)'s attendance at (CV)(TMCF) or participation in (CV)(TMCF) program. On my behalf and of my children, I hereby release, covenant not to sue, discharge, and hold harmless (CV)(TMCF), its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of (CV)(TMCF), its employees, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any (CV)(TMCF) program.
